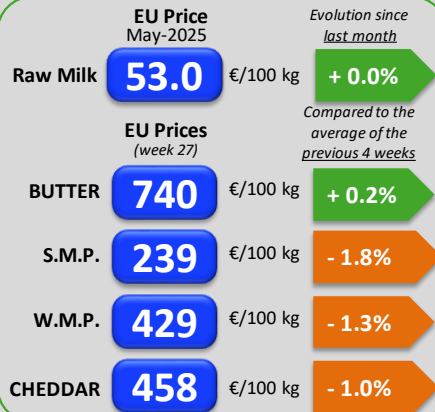
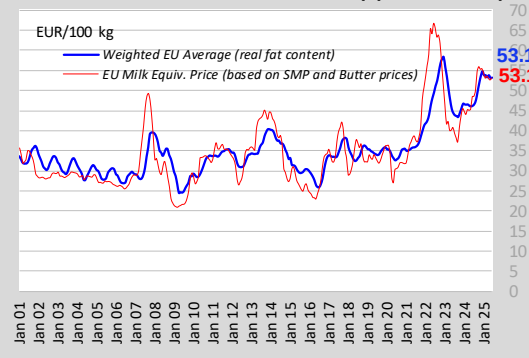


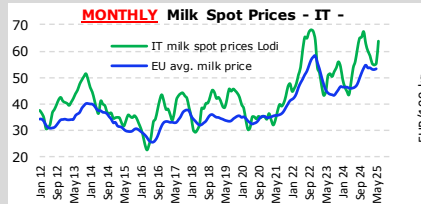
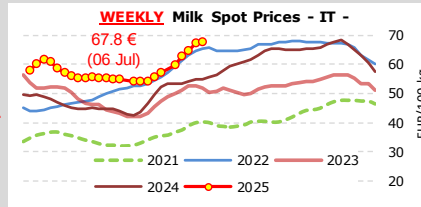


EU evolutive¹ Raw Milk Prices Evolution (up to Jun 2025²)

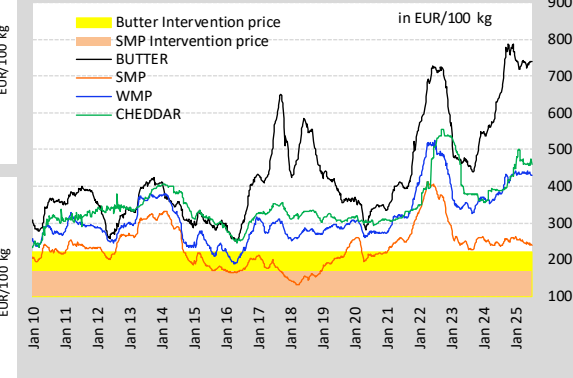

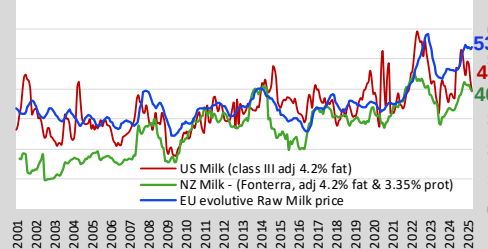
EU average quotations of main commodities



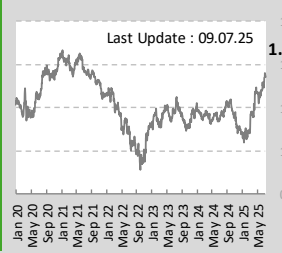

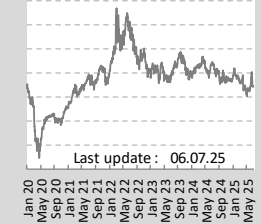
US, NZ and EU milk prices up to May 2025



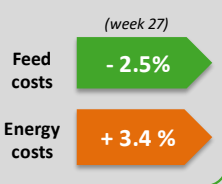
EUR / USD Exchange Rate



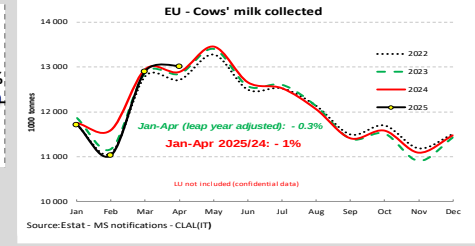
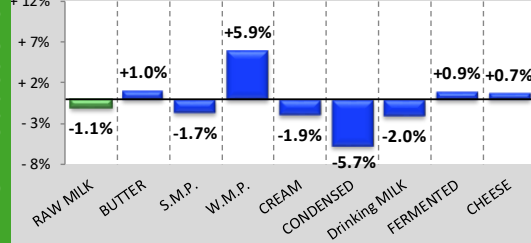
OIL : Europe Brent Spot Price (USD/Barrel)



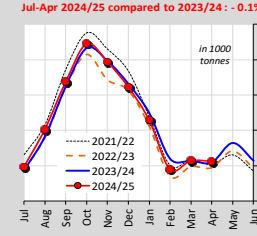
Feed / Energy quotations (evolution compared to the average of the previous 4 weeks)



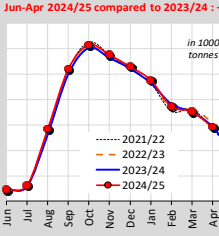
EU Productions (Jan-Apr 2025 compared to Jan-Apr 2024)



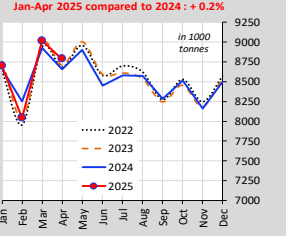
Australian milk production

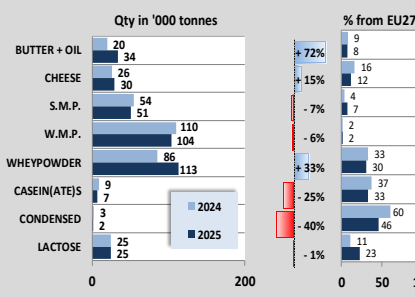
